VNA Legislative Day

On Tuesday February 16th, 2016, the Virginia Nurses' Association held their annual Legislative Day in downtown Richmond. This event brought together nurses, managers, students and the lobbyists who represent the VNA at Virginia's General Assembly each year.

The day started off with the keynote speaker, Dr. Marissa Levine, who is the Virginia State Health Commissioner. She focused her address on how to "design healthy communities", posing the question of what our communities would look like if they were intentionally designed to ensure health and well-being for all". Rather than focusing on health as something we restore when we loose it, she spoke on how this needs to be something that is always maintained. Primary prevention is key to promote the culture of health that the commonwealth strives for. Dr. Levine discussed how cost is the drive for change, and that at the policy level, the state needs to address where we invest our limited resources.

Following Dr. Levine, Andrew Lamar, one of the VNA's lobbyist took the stage to discuss the current pieces of legislation that are being pushed during the 2016 General Assembly. The main topic of discussion were changes to the scope of practice for advanced practice nurses. He mentioned new changes in the practice of Nurse Midwives, Certified Registered Nurse Anesthetists, Clinical Nurse Specialists, and finally Nurse Practitioners. It was during this segment of the day that many nurses spoke up and advocated for an increase in the scope of practice to allow for more autonomy from the medical community.

First Lady Dorothy McAullife made a brief appearance to speak about eliminating childhood hunger by broadening access to proper nutrition. She pointed out that 1 in 45 voters are nurses, and yet nationally only 45% of schools have a full time nurse. She pushed for nurses to be active voters on the issues that they see most commonly in their communities.

The next speaker was Jay P. Douglass, the Executive Director of the Virginia Board of Nursing. She spoke on the changes to the requirements for licensure. As of January 1st of 2016, all nurses applying for licensure in the state of Virginia must attain a state and national fingerprint criminal background check. This applies to students registering to take the NCLEX as well as nurses coming in from another state and those needing reinstatement.

Douglass also discussed the Nurse License Compact, or the laws that allow 25 states to hold a "joint" license, with only minimal differences in their requirements. For instance, if you hold a nursing license in Virginia, but take another job in Colorado, your Virginia nursing license is still valid while working there.

The event overall had a great turnout, and was a wonderful experience to attend as a nursing student. While the vast majority of attendees were licensed nurses, having the knowledge of legislative action and duties as a student will help to prepare us all for the political side of the environment we will enter upon our eventual licensure.
